# MESSAGE FROM THE MANAGEMENT OF THE OSCE ACADEMY

Dear Valued Readers,

On behalf of our esteemed community of students. faculty, alumni network, researchers and staff, I am proud to share with our community our 20th Annual Report for the year ending 31 December 2023 when I served as acting director. It demonstrates the impact of our indispensability, high quality, uniqueness and inclusivity throughout the ended year. It is filled with a comprehensive overview of the programmatic developments, including the achievements attained in running three Master of Science Programmes in Politics and Security, Economic Governance and Development and in Human Rights and Sustainability; and a Bachelor of Arts Programme in Economics. You will be introduced to the recent developments achieved by the OSCE Academy in implementing a series of its professional trainings, research and publications activities, joint projects carried out in partnership with various research, think tanks and educational institutions and organizations. We will proudly update you on our alumni activities, tell more about the newly established international and regional partnerships and present other accomplishments reached by the Academy's team via empowering excellent learning through experience and developments, continuing to achieve academic excellence in the region, demonstrating professional scholarly impact, sustaining regional and global enlargement with existing and new partners in support of the Academy's efforts to strengthen a truly regional academic and educational centre.

As you will see, in 2023 the Academy's strong position in the regional educational system proved its resiliency, which is designed around our students' aspirations, the regional needs of educated professionals and highly trained researchers, alumni community engagement, and our unique location in Central Asia. The Academy's qualified staff, faculty, research team, we all proudly remained committed to ensuring the Academy's sustainable growth and development.

On 17 February, the OSCE Academy Alumni community has proudly expanded to further 25 students, increasing the total number of alumni to 619. Shortly after, our Master's Programme in Economic Governance and Development was awarded with a certificate of international programme accreditation, formalizing the Programme's compliance with international quality assurance requirements and adherence to international education standards. In June we successfully reached several unprecedented milestones expressed in the: launch of the third Master of Liberal Arts and Sciences in Human Rights and Sustainability Programme, implemented jointly with the Global Campus of Human Rights in Venice and co-financed by the European Union: international accreditation recognition of our oldest Master's Programme in Politics and Security. In August our 6th Summer School welcomed 70 participants in total. Thus, 48 students, selected out of 1825 applicants for the Master of Arts Programmes were joined by the second cohort of 25 Bachelor of Arts students in September, selected out of 2435 applicants. For the newly enrolled cohorts of students many travel and visa opportunities were improved significantly, although leaving certain related challenges to students from Afghanistan and thus affecting their ability to secure visas and travel to Kyrgyzstan.

Throughout 2023 the Academy has been continuing and growing its publication record which was reflected in 8 new Policy Briefs, 2 Research papers, 3 Springer Open Access Publications, 1 Working paper, 3 Research papers, and 4 AGRUMIG project Paper series. Six quest and public lectures, 3 book launches, 5 workshops, 3 certificate trainings, and 2 conferences were organized by the OSCE Academy in cooperation with faculty members, research and postdoctoral fellows. The OSCE Academy successfully continued its 8-partnership projects implementation in cooperation with the Foundation for Open Societies Institute, Global Engagement Center, UK Foreign, Commonwealth & Development Office, National Endowment for Democracy, CAREC, Bielefeld University, University of Dortmund, European Union's Horizon 2020 Programme.

Our mission also enables exceptional partnerships which were developed and stocked in 2023 with the International University of Kyrgyzstan, Japan Central Asia Friendship Association, Kırşehir Ahi Evran University (Türkiye), the Kyrgyz Economic University, the Leibniz Institute for East and Southeast European Studies in Regensburg (Germany), the Narxoz University (Kazakhstan), the National University of Mongolia (Mongolia), the PIL Research Company (Kyrgyzstan), the South East European University (North Macedonia), the State Agency for the Protection of Personal Data under the Cabinet of Ministers of the Kyrgyz Republic, the University of Siena (Italy).

To ensure that our 619 graduates were market-ready and professionally demanded by the states, economies, the societies, and internationally, the OSCE Academy continued to lead, support with scholarships, internships and by offering various opportunities through organizing Chapter meetings (in Tashkent, Astana and Vienna), accepted 4 fellows for the Junior Teaching Fellowship programme and 4 fellows for the Junior Public Officers Programme. The Academy organized: International Spring School on "Human Rights & Good Governance for Security in Central Asia," in co-operation with the OSCE Programme Office in Bishkek and the Global Campus of Human Rights in Venice and the workshop on "Contemporary Security Sector Governance and Reform" conducted by the OSCE Conflict Prevention Centre and the Geneva Centre for Security Sector Governance. In Fall our graduates happily benefitted from participating in the joint Alumni/Experts Conference: "Central Asia: Comprehensive Security and Sustainable Development", organized by the OSCE Academy jointly with the University of Siena and receiving one scholarship within the OSCE Parliamentary Assembly Research Fellowship and Master of Advanced Studies Scholarship programme jointly run by the GCSP and the Global Studies Institute (University of Geneva). We further enhanced our cooperation within Erasmus + (with: CAGHAN - Central Asia -Governance, History, Anthropology and Neighborhoods; JoPSciP, EUPeace) and Erasmus+ mobilities (with the Aleksanteri Institute, University of Helsinki; Freiburg University in Germany; the National University of Political Studies and Public Administration in Romania; the Philipps-University Marburg in Germany). As first and proud recipient of a grant from Jean Monnet Module on EU Climate Policy we organized a roundtable on "Climate Policy in Central Asia and Research Potential". We continued our cooperation with MOCCA: Multilevel Orders of Corruption in Central Asia," a Horizon 2020 project led by the University of Lund (Sweden) and we have proudly completed cooperation on the project titled: "Enhancing youth crime and drug use prevention through education on legality and awareness campaigns addressing threats of organized crime and corruption" launched and implemented by the OSCE Transnational Threats Department and the Office of the Co-ordinator of OSCE Economic and Environmental Activities in close co-ordination with the United Nations Office on Drugs and Crime.

Throughout 2023 all our developments and achievements were strongly supported by generous contributions from our regular and new supporters: Austria, the European Union, Finland, France, Germany, Italy, Norway via the Norwegian Institute of International Affairs, Poland, Switzerland, the United Kingdom and the United States, that pledged funding to cover the Academy's related extra-budgetary costs, provided third party funding. These pledges come in addition to the funding received from the Unified Budget and the OSCE Programme Office in Bishkek covering the Academy's administrative costs. The Government of the Kyrgyz Republic continued providing its vital in-kind support to the Academy in the form of a building hosting our campus.

It is undisputable that the OSCE Academy's growth has come directly from the generous and stable support of our donors and the culture of giving that they helped to build. The OSCE Academy avails itself of this opportunity to convey sincere gratitude and address our kind request to continue in the coming months and years supporting the growing developments of the OSCE Academy to make our further possibilities on shaping a new generation of highly educated professionals, engaging into professional research vital for the wider region of Central Asia, and on stimulating policy formation processes in line with the principles and objectives of the OSCE, infinite. We look forward to the future, and all that we will accomplish together.

### MAIN ADMINISTRATIVE HIGHLIGHTS

By the Decision of the OSCE Academy's Board of Trustees dated 28 November 2022 Dr. Indira Satarkulova – Deputy Director was appointed Acting Director of the OSCE Academy in Bishkek.

In May 2023, the Acting Director of the OSCE Academy, Dr. Indira Satarkulova addressed the 1424th Plenary Meeting of the OSCE Permanent Council in Vienna within the Annual Report presentation by H.E. Ambassador Alexey Rogov, Head of the OSCE Programme Office in Bishkek and the Chairperson of the OSCE Academy Board of Trustees.

In February and November 2023, the OSCE Academy's Board of Trustees held two meetings.

In February an Agreement between the State Enterprise "Department of State Buildings" and the OSCE Academy related to the free use of the state building for educational needs was renewed.

### **EDUCATION**



In 2023 the OSCE Academy continued to focus on providing high-guality education. Throughout the year, the Academy's efforts were concentrated on ensuring the quality of courses, improving students' research skills, and providing them with relevant experiences and networking through international internships. Hard work and commitment of the faculty to contribute to the studies and the professional development of each and every student, revising the curriculum structure to enhance the effectiveness and sustainability of the programmes, as well as student engagement remain important aspects of the education process at the Academy. In addition to the Bishkek-based permanent faculty members, leading academics from the OSCE Academy's partner institutions continued to provide a great opportunity for the students to develop knowledge on particular subjects through conducting intensive practice-oriented modules.

The OSCE Academy continuously evaluates the implementation of its master programmes, which includes a self-assessment and an independent accreditation process. In this past year, the MA programme in Politics & Security (Central Asia) received its five-year international accreditation from the Agency for Quality Assurance in Education "EdNet". The comprehensive accreditation process, which included evaluation of the students' work, faculty and staff over the previous five years confirmed the quality of the programme.

While the MA in Economic Governance & Development and the MA in Politics & Secu-

rity (Central Asia) programmes continue to graduate students that are highly demanded in governance structures and international organizations, in civil society and in academia, in September 2023 the OSCE Academy welcomed students of the newly launched Master Programme in Liberal Arts in Human Rights and Sustainability.

The Master Programme in Liberal Arts in Human Rights and Sustainability is the first master level programme in the Central Asian region aiming for a new generation of human rights and sustainability defenders. This programme is the eights regional Master Programme run by the Global Campus of Human Rights in Venice, co-funded by the European Union. It advocates a world where human dignity, equality, freedom, human security, sustainable development, democracy, the rule of law, and respect for all human rights are realized.

The opening ceremony of the MAHRS programme was held on 29 September 2023 at the same time commemorating the 75th Anniversary of the Universal Declaration of Human Rights (UDHR). The opening ceremony of the programme brought together international experts and guests from the Global Campus of Human Rights, United Nations (UN), the Organization for Security and Co-operation in Europe (OSCE), the European Union (EU), academia, and civil society.

Simultaneously with the OSCE Academy's graduate students, two cohorts of undergraduate students from Kazakhstan,



### SUMMER SCHOOL PROGRAMME



In August 2023, the OSCE Academy hosted its annual Summer School, which included preparatory courses, outdoor classes, and a closing ceremony held at Issyk-Kul. In this past year, the Summer School welcomed 70 participants from Central Asian countries, Afghanistan, Mongolia, Russia, and Turkey. Newly enrolled students of the OSCE Academy's MA Programmes in Politics & Security and in Economic Governance & Development as well as young graduates from other universities had a chance to understand how the knowledge and skills gained during the Summer School can contribute to their ongoing academic studies and future professional pursuits. The Summer School programme offered courses specifically designed to equip participants with the necessary skill set to enter one of the OSCE Academy's MA programmes or another international graduate course. These included "Mathematics for Economists," "Academic Writing and Honesty," and "Introduction to Research Methods in Social Sciences." The courses were taught by a combination of the OSCE Academy's permanent faculty and recruited lecturers.

### **ADMISSION PROCESS 2023**

In 2023, the Academy successfully recruited students to its MA Programmes, including to newly launched MA Programme in Liberal Arts in Human Rights and Sustainability (MAHRS). Comparing 2775 applications received in the previous year, the number of applications for the three MA Programmes reached to 1825. However, the decrease in the number of received applications did not affect their quality. Thus, 252 candidates have been short-listed and invited for the entrance examinations. Most of the candidates have been invited for the examinations in Astana, Bishkek, Dushanbe and Tashkent. The remaining applicants have been examined online making a good combination of offline and online formats.

Practice of the online interviews have been continued, and 146 applicants have been interviewed, 60 for the MA in PS, 41 for the MA in EGD, and 45 for the MAHRS Programme. Overall, 70 candidates have been selected and joined the Academy's MA Programmes.

Admission to the Bachelor Programme in Economics took place simultaneously with the MA Programmes, and 25 students have been enrolled among 2435 applicants. Selection of applicants have been based on the results of the entrance examinations that took place in Astana, Bishkek, Dushanbe and Tashkent. The online examinations have been offered for applicants from Afghanistan, Mongolia and Turkmenistan.

### **INTERNSHIPS 2023**

In accordance with the academic regulations of the MA Programme in Politics and Security (Central Asia) and MA Programme in Economic Governance and Development, students are obliged to conduct internship during the Fall semester of the programme. Internship is an important part of practical education and a prerequisite for successful studies of students in view of their future professional activities.

Winter and spring semesters were followed by the MA thesis research period and internships. MA Programme students in Politics and Security (Central Asia) and in Economic Governance and Development completed their internships in offline mode, except for two students from Afghanistan, who completed their internships in online mode.

# **RESEARCH AND TRAINING UNIT**

During 2023, the OSCE Academy continued hosting Postdoctoral and Associate Research Fellows, produced various publications including an edited volume for Springer Open Access, and implementing research projects. Trainings, workshops, conferences, book launches, and public lectures were regularly held in hybrid and online formats, engaging local and international participants. Overall, the Academy published a number of research reports, policy briefs and other publications.

### **PROFESSIONAL TRAINING**

### CERTIFICATE TRAININGS: "PROJECT MANAGEMENT", "PEACE AND CONFLICT" AND "CONFLICT SENSITIVE JOURNALISM"

In the year of 2023, the OSCE Academy organized three professional training seminars: on Project Management from 7 to 11 August, Peace and Conflict from 17 to 21 September and Conflict Sensitive Journalism from 25 to 28 September.

These trainings were designed for young and mid-career professionals from Kazakhstan, Kyrgyzstan, Mongolia, Turkmenistan, Uzbekistan and Afghanistan (Bishkek based) representing various sectors, such as international, development and non-governmental (non-profit) organizations, governmental bodies, research and academic institutions, and other civil society representatives. The training on "Project Management" enrolled 22 young professionals (13 women, 9 men) and provided participants with a holistic understanding of project management, where they had a chance to improve their skills to efficiently execute projects.



Trainings "Peace and Conflict" and "Conflict Sensitive Journalism" were conducted by Mr. Oliver Wiechmann, trainer from Crisis Simulation for Peace (CRISP) – an organization, based in Berlin, Germany that specializes in organizing training seminars in the fields of conflict transformation, civic education, and citizen participation. Mr. Ulugbek Nurumbetov, director of the Institute for Peace and Development and Dr. Elira Turdubaeva, Head of the Journalism and Mass Communications Programme at the International Ala-Too University in Kyrgyzstan were assistant trainers respectively. From the "Peace and Conflict" seminar participants learned about key terms, concepts and tools of conflict analysis. The interactive component of the training included conflict simulation game KODORI, where participants had a chance to play a role of key stakeholders and negotiate a comprehensive peace agreement. The "Conflict Sensitive Journalism" training taught participants (9 men, 11 women) were enrolled to the Peace and Conflict Training while further 17 participants (11 women and 6 men) took the training on Conflict Sensitive Journalism.

# ONLINE WORKSHOP: "CENTRAL ASIA'S INTERNATIONAL RELATIONS: DECISION-MAKING ACTORS AND PROCESSES"

On **28** April the OSCE Academy hosted an online workshop titled as "Central Asia's International Relations: Decision-Making Actors and Processes." The workshop was organized by Dr. Shairbek Dzhuraev, Post-doctoral Research Fellow at the OSCE Academy, within the Postdoctoral Fellowship Programme implemented in partnership with the Volkswagen Foundation. The workshop covered individual Central Asian states and their external partners, with speakers shedding light on the actors and factors that shape policy processes and decisions. The speakers included Dr. Nurseit Niyazbekov from KIMEP University in Almaty, Dr. Farkhod Tolipov from Bilim Karvoni in Tashkent, Dr. Karolina Kluczewska from the University of Ghent in Belgium, and Dr. Emil Dzhuraev from the OSCE Academy in Bishkek. Speakers also included Dr. Paul Stronski from the Carnegie Endowment for International Peace, Dr. Aijan Sharshenova from the OSCE Academy in Bishkek, Mr. Vito Acosta from Crossroads Central Asia, and Mr. Jos Boonstra from EUCAM at the Centre for European Security Studies (CESS).

### POLICY DISCUSSION: "WINNING HEARTS AND MINDS ABROAD: PUBLIC DIPLOMACY TALK"

On **26 June** the OSCE Academy organized a policy discussion: "Winning Hearts and Minds Abroad: Public Diplomacy Talk" for MA students of the Academy. This discussion featured two foreign policy experts: Professor Erman Akilli from Kırşehir Ahi Evran University, and Dr. Aijan Sharshenova, Postdoctoral Research Fellow at the OSCE Academy in Bishkek, who discussed the theory and practice of public diplomacy. The discussion focused on the implementation of public diplomacy in Eurasia and explore public diplomacy as a foreign policy and nation-branding instrument.

### CONFERENCE: "CHINA-CENTRAL ASIA AFFAIRS: PERSPECTIVES FROM JUNIOR RESEARCH FELLOWS"

On **27-28 June** the OSCE Academy organized a two-day conference on "China-Central Asia Affairs: Perspectives from Junior Research Fellows". Three Junior Research Fellows (JRF) of the OSCE Academy, Adina Masalbekova, Dr. Berikbol Dukeyev, and Mukhammadsodik Donaev presented their articles focused on China's presence in Central Asia. This conference was organized as part of the project "Pilot Project for Central Asian Centre for China Affairs", which was supported by the National Endowment for Democracy (www.ned.org).

The conference hosted 9 international experts on China, including Raffaello Pantucci, Senior Fellow at RUSI/RSIS, Dr. Dilini Pathirana, Senior Lecturer at the University of Colombo, Dr. Erman Akıllı, Director of Foreign Affairs Office at Kırşehir Ahi Evran University, Dr. Jabin T. Jacob, Associate Professor at Shiv Nadar University, Akram Umarov, Deputy Director at the Institute for Advanced International Studies (IAIS), Catherine Putz, Managing Editor at The Diplomat, Dr. Plamen Tonchev, Head of Asia Unit at the Athens based Institute of International Economic Relations (IIER), Dr. Brian Carlson, Head of the Global Security Team of the Think Tank at the Center for Security Studies (CSS), Frank Maracchione, Co-convener of Sheffield Political Economy Research Institute.





### **BOOK LAUNCH EVENTS**

In the year of 2023, the OSCE Academy organized three book launch events. On **28 March** Cholpon Orozobekova, Director of the Bulan Institute for Peace Innovations, and former Associate Research Fellow at the OSCE Academy organized a launch of her book titled as: "Foreign Fighters and International Peace: Joining Global Jihad and Marching Back Home". Ms. Orozobekova's book focuses on real-life experiences and hardships of individuals, particularly women and children. The event was attended by researchers, academics, and journalists.

The remaining two book launches were conducted on **24 April** on the edited volume "Climate Change in Central Asia – Decarbonization, Energy Transition and Climate Policy" and, on 9 November on another edited volume on "Researching Central Asia: Navigating Positionality in the Field". Both books were published as part of the Springer Briefs in Political Science book series, as a result of the OSCE Academy's multi-year cooperation with Springer.

The edited volume on "Climate Change in Central Asia – Decarbonization, Energy Transition and Climate Policy," was co-authored by Dr. Rahat Sabyrbekov, Post-Doctoral Research Fellows of the OSCE Academy and Dr. Indra Overland and Dr. Roman Vakulchuk from the Norwegian Institute of International Affairs. On the book talk, each author presented their research on climate change in Central Asia. The edited volume on "Researching Central Asia: Navigating Positionality in the Field" was co-authored by Dr. Aijan Sharshenova, Lecturer and Post-Doctoral Research Fellow of the OSCE Academy and Dr. Jasmin Dall'Agnola, Postdoctoral Researcher at the George Washington University's Institute for European, Russian, and Eurasian Studies (IERES). Washington D.C. The speakers who contributed to this volume, discussed struggles and challenges they faced during their research in Central Asia. Specifically, they discussed the impact of such factors as race, gender, institutional affiliation, languages spoken, and various other aspects of their identity. Both book launches were organized in a hybrid format and attracted a lot of participants.




#### PUBLIC TALKS

On **31 May** the OSCE Academy organized an online Public Lecture by Barbara Meier, Associate Research Fellow of the Academy on the topic: "The Geopolitical Everyday: Capturing Transnational Attractions in Sympathies of Students in Bishkek and Osh". Ms. Meier's research project in Kyrgyzstan focused on transnational aspirations







Irrigation and Insurgency: Can Public Infrastructure Mitigate Climate-Induced Conflict in Alghanistan? Penghan Pat Ibanity at Hinkingh December 2023 in students' educational choices, such as language learning or interest in specific study programmes. She discussed the concept of 'sympathy' and its application in the context of transnational justice.

On **30** August Dr. Aliya Assubayeva, a Research Fellow at the OSCE Academy and a Research Associate at the Center for International Development and Environmental Research, Justus Liebig University Giessen, Germany, delivered a public lecture titled "Uncertainties in Water Security Decision-Making in Central Asia." During the lecture, Dr. Assubayeva presented her research paper, which had been published as part of her Research Fellowship at the OSCE Academy, focusing on the relevant topic of water security. The lecture focused on an exploration of the sources of endogenous uncertainty in water resource management, using case studies from Kazakhstan and the Kyrgyz Republic. Dr. Assubayeva emphasized the endogenous uncertainties that emerge from within the decision-making system and identified key factors for mitigating them. These factors included the improvement of data availability and analysis, the establishment of resilient infrastructure, and the enhancement of overall capacity.

On **14 September** the OSCE Academy held a public lecture on the topic of the Regional Security Regime Emerging in Central Asia. The lecture was led by Anna Jordanova, a Ph.D. Candidate at the Institute of International Studies at Charles University in Prague and a Research Fellow at the OSCE Academy. She presented the policy brief that elaborates on the problem of rising uncertainty across and within the Central Asian region and the reaction of the respective national regimes. During the presentation, Ms. Jordanova introduced the concept of the international regime as a form of cooperation and communication based on shared norms and practices, responding to member states' common interests. She also focused on the OSCE's presence in the region and gave recommendations.

On **07 December** Pengshan Pan, former Research Fellow at the OSCE Academy and a doctoral candidate at the Graduate School of Public and International Affairs at the University of Pittsburgh, delivered a public lecture on 'Irrigation and Insurgency: Can Public Infrastructure Mitigate Climate-Induced Conflict in Afghanistan?' Pengshan Pan examined the role of public irrigation infrastructure in mitigating climate-induced conflicts in Afghanistan, focusing on individual engagement with armed groups. Furthermore, he analyzed the differentiated effectiveness of various irrigation systems in addressing water-related conflicts. He also gave policy recommendations with a focus on local governance.

# JOINT INITIATIVES



### **GUEST LECTURES**

On **1 March** Prof. Andrew Mertha, George and Sadie Hyman Professor of China Studies and Vice Dean of the Johns Hopkins University School of Advanced International Studies (SAIS), delivered a guest lecture on China's Fragmented Foreign Policy to MA students of the OSCE Academy. The lecture was followed by a round table discussion with project researchers of the Academy Asylgul Kanatbekova (Senior Researcher), Adinai Masalbekova (Junior Research Fellow), and Nargiza Muratalieva, Associate Research Fellow.

On **12 April** Dr. Brian Carlson delivered a guest lecture on "China-Russia Relations in a Changing Central Asia". The lecture was attended by MA students in the Politics and Security Programme. Dr. Brian Carlson is head of the Global Security Team of the Think Tank at the Center for Security Studies (CSS). He holds a Ph.D. in International Relations from the Johns Hopkins School of Advanced International Studies (SAIS) in Washington, D.C. On the lecture, he captured the China-Russia relationship in Central Asia from the period of the break-up of the Soviet Union to recent time. These guest lectures were organized in cooperation with the American Councils for International Education.

### RESEARCH WORKSHOP: "CONNECTING PROTEST RESEARCH(ERS)."



On **15-17 May** the OSCE Academy hosted a 3-day research workshop titled "Connecting Protest Research(ers)." The workshop was delivered to 28 young scholars from Afghanistan, Kazakhstan, Kyrgyzstan, Tajikistan, and Uzbekistan. The workshop was part of an ongoing research project conducted by Dr. Asel Doolotkeldieva, Non-Resident Research Fellow, George Washington University, in partnership with Dr. Beate Eschment, Zentrum für Osteuropa und internationale Studien (ZOiS) in Berlin and funded by the German Academic Exchange Service (DAAD). Scholars from Central Asia and Germany who study the topic of protests and other forms of contentious politics took part in the event. During the three days, participants had an opportunity to present their research projects and discuss empirical cases as well as methodological and ethical challenges related to protest research in non-Western contexts.

### **REPORT LAUNCH: "CENTRAL ASIA FORECASTING"**

On **19 October** the OSCE Academy hosted an event in a hybrid format devoted to the launch of the second edition of Central Asia Forecasting Project Report. "Central Asia Forecasting" jointly organized with the Friedrich Ebert Stiftung in Kazakhstan which served as a platform to present the findings of the survey and to discuss political, economic, and environmental aspects of Central Asia's development. "Central Asia Forecasting" is a collaborative analytical project that aims to identify and track regional trends in Central Asia over time. The first study was launched in 2021, and the current edition is an updated follow-up on the first report. The report discussion was held by Dr. Aijan Sharshenova, Research Fellow at the Crossroads Central Asia Research Institute, Dr. Shairbek Dzhuraev, President of the Crossroads Central Asia Research Institute, and Dr. Aliya Tskhay, Research Fellow at the University of St. Andrews, who elaborated on the political, economic, and environmental dimensions of Central Asia's ongoing development.



### JOINT EXPERT/ALUMNI CONFERENCE ON "CENTRAL ASIA: COMPREHENSIVE SECURITY AND SUSTAINABLE DEVELOPMENT"

On **4-5 November** a Joint Expert/Alumni Conference on "Central Asia: Comprehensive Security and Sustainable Development" was held at the OSCE Academy. The event was co-organized by the University of Siena. The two-day conference focused on gender, youth, and climate change issues in Central Asia, and a round table discussion on "The OSCE and the EU in the Reshaped Central Asia Geopolitical Scenario". The keynote speech was delivered by Dr. Aksana Ismailbekova, Postdoctoral research fellow at the Leibniz-Zentrum Moderner Orient on the topic of "Daughters as Ojiza: Daughter's Marriage, Security and Care among Uzbeks in Southern Kyrgyzstan." Other speakers included alumni of the OSCE Academy, external experts, Dr. Fabio Indeo, Researcher and representative of the University of Siena, and Mr. Colin McCullough, Senior Planning and Co-ordination Officer at the OSCE Programme Office in Bishkek. The conference was organized in a hybrid format.

#### Dr. Shairbek Dzhuraev



Dr. Shairbek Dzhuraev's research interests include a wide range of political and policy issues in Central Asia, with particular focus on foreign policy, political institutions and regime dynamics in the region. #### **VINCENZO ALFANO**

Research topic: Governance, Non-Pharmaceutical Interventions (NPIs), and Vaccination Rates. The Second and Third Waves of the COVID-19 Pandemic in Central Asia: Implications for Good Governance

Dr. Vincenzo Alfano holds the position of Research Fellow in Political Economy at the University of Napoli Parthenope. He is also an associate to the Institute for the Mediterranean of the Italian National Research Council and to the Center for Economic Studies – CESifo. Also, he is a research fellow at the Global Labour Organization – GLO and a fellow at Italy's National University Centre for Applied Economic Studies – CiMET. Moreover, he serves as a board member of several scientific journals and is Academic Editor for Plos One. Before being appointed to this position, Dr. Alfano had worked as Senior Lecturer in Economics at the Westminster International University in Tashkent. Dr. Alfano has broad research interests; his studies extend to different incentive systems, the institutions that create them, and their effects, and interactions in a variety of different contexts. In particular, his recent contributions focus on a variety of subjects, from health economics and public health to the economic impact of religion and sports economics, also within the context of Central Asia.



#### **ALBERICA CAMERANI**

Research topic: Enterprising Women in Kyrgyzstan: Insights into the Interaction of Gender and Entrepreneurship

Alberica Camerani is a doctoral researcher at Dublin City University, where she also works as a Marie Curie Early Stage Researcher within the Innovative Training Network "Markets" (EU-MSCA grant). In her doctoral project, she focuses on the influence of the socio-cultural environment on female entrepreneurship in Kyrgyzstan, where she has three years of working and researching experience. More broadly, her research interests encompass gender, nation-building, and social transformation in Central Asia. She holds a double master's degree from the University College of London and the Higher School of Economics in Economy, State and Society with a focus on the post-Soviet space. Recently, she joined the World Economic Forum Expert Network as a member advising on Gender Equality, Entrepreneurship and Future of Government.

## Research topic: Understanding Informality in Kazakhstan: A Study of Informal Entrepreneurial Attitudes, Behaviours and Practices

Tommaso Aguzzi is a Ph.D. Candidate within the Innovative Training Network MARKETS programme at Tallinn University of Technology (TalTech), Estonia. He holds a double Master's degree in Global Studies from the University of Vienna and Roskilde University, as well as a Bachelor's degree in International Development and Cooperation from the University of Bologna. His research interests focus on the practices of informal entrepreneurs operating in the Central Asian region. ## Research topic: Activating the Unemployed? Employment Support Policies in Kazakhstan and Kyrgyzstan

Eugenia Pesci is a doctoral researcher at the Aleksanteri Institute, University of Helsinki. She is a Marie Curie early-stage Researcher in the Horizon 2020-funded International Training Network "Markets". Her research focuses on the development of labour market and employment policies in Kyrgyzstan and Kazakhstan. She is interested in analysing how global active labour market policies are translated and adapted in the context of highly informalised labour markets, by investigating how the notion of unemployment is being constructed through the activation framework in social policy. She is particularly interested in the perspective of the local bureaucracies and in understanding how they translate the policies into practices at the street-level. Methodologically, her study relies on in-depth interviews with a wide range of local and international stakeholders, participant observation, and analysis of official legislation, policies, programs, and reports. She holds a Master's degree in East European Studies from the University of Bologna, Italy.



### **ANNA JORDANOVA**

## Research topic: The Behavior of the Central Asian Elites on the International Level: the unique factors and local conditions determining their policies and politics

Anna Jordanova is a Ph.D Candidate at the Institute of International Studies at Charles University in Prague. Her doctoral research focuses on regional and international cooperation across Central Asia and its extended neighborhood. She focuses on new trajectories of the respective Central Asian states' foreign policies, especially following the renewed Russian aggression against Ukraine, including its political and economic consequences.

The fellowship at the OSCE Academy is coordinated and co-funded by the Bourse&Bazaar foundation as a part of a larger research of current cooperation trends of Central Asian states with partners beyond the traditional Russia-China scheme.

### JASMIN DALL'AGNOLA

Research topic: The Implications of the COVID-19 Crisis for Smart City Technologies in Central Asia

Dr. Jasmin Dall'Agnola holds a PhD in Politics and International Relations from Oxford Brookes University and a Master in Political Science and Slavic Linguistics from the University of Zurich. Her research interest centers on the relationship between gender, governance and technology in post-Soviet Central Asia. Her postdoc project has been awarded a prestigious two-year, full-time Postdoctoral Mobility Fellowship from the Swiss National Science Foundation to explore the implications of the COVID-19 pandemic on smart city technologies in Central Asia. Central Asian governments are known for using smart city innovations to assist in waste management and policing urban centers. However, there is little research to date assessing the extent to which the COVID-19 crisis is fuelling the spread of smart city technologies across Central Asian cities. Nor are there any studies into the wider Central Asian public's attitudes toward them. Jasmin's postdoc project is designed to fill these voids. Methodologically, her study will evaluate survey data, focus group interviews, along with a visual exploration of smart city installations in the Central Asian cities of Almaty, Bishkek, Dushanbe, and Tashkent.

### **PROJECT RESEARCHERS**

The OSCE Academy hosted 7 project researchers within the framework of three research projects: 1) "Pilot Project for Central Asian Center for China Affairs", funded by the Foundation Open Society Institute (FOSI), "Analyzing Chinese Influence in Central Asia", funded by the National Endowment for Democracy (NED) and "Chinese Information Operation in the Kyrgyz Republic", funded by the Global Engagement Center (GEC).



#### TEMUR UMAROV, RESEARCH FELLOW (FOSI) AND RESEARCH ASSOCIATE (NED)

Mr. Temur Umarov is a fellow at the Carnegie Endowment for International Peace. His research is focused on the domestic and foreign policies of the Central Asian republics, as well as trilateral relations between Central Asia, the Russian Federation and the People's Republic of China. A native of Uzbekistan, Umarov possesses degrees in China Studies and International Relations from the Russian Presidential Academy of National Economy and Public Administration, and the Moscow State Institute of International Relations (MGIMO). He holds a Master's degree in World Economics from the University of International Business and Economics in Beijing. He is also an alumnus of the Carnegie-Tsinghua Center's Young Ambassadors and the Carnegie Endowment's Central Asian Futures Programmes. At the OSCE Academy, Mr. Umarov conducted research on the role of Uzbekistan's stance on China, and delivered a course on East Asian Politics for BA students and participated in other events.



### SHERZOD SHAMIEV, RESEARCH FELLOW (FOSI)

Mr. Sherzod Shamiev is a recent graduate of OSCE Academy and a researcher at the Center for Sociological Research "Zerkalo" in Tajikistan. He completed his undergraduate degree in Political Science and International Relations at the American University in Bulgaria. He has carried out research and project evaluations for various local and international organizations. His research interests focus on Sino-Central Asian relations, as well as on the security of Central Asia and Eurasia. He has also been researching on various security issues during his internships at the Geneva Centre for Security Policy and ithe Hudson Institute's Center for Political-Military Analysis. At the OSCE Academy, Mr. Shamiev conducted research on China's investments in Tajikistan.



#### ADINA MASALBEKOVA (JUNIOR RESEARCH FELLOW, NED)

Ms. Adina Masalbekova's research interests include China-Central Asia relations; Socio-political development in post-Communist Central Asia; Religious fundamentalism. Adina holds a Bachelor's degree in Linguistics (Chinese language) from Bishkek State University and a Master's degree in Political Theory from East China Normal University in Shanghai. Previously, she was a Research Assistant at the Shanghai Academy of Social Sciences and the Australian National University. At the OSCE Academy, Adina's research focused on evaluating impacts of China's cultural diplomacy via higher education in Kyrgyzstan, through the perspective of employment, understanding of current Chinese politics and contribution to political careers.



### **BERIKBOL DUKEYEV (JUNIOR RESEARCH FELLOW, NED)**

Dr. Berikbol Dukeyev's research interests include intersections of politics, society, and security. He is the author of the peer-reviewed article "Kazakhstan in World War II: Authors and Publishers of Post-1991 History Textbooks," published by Central Asian Affairs, and an analytical online article "Do Kazakhstanis care about their kin in Xinjiang?" published by Open Democracy. He is a graduate of MA in Politics and Security (Central Asia) from the OSCE Academy in Bishkek and has a BA in Political Science from Al-Farabi Kazakh National University. Previously, he was a Sessional Academic at ANU, Central Asia Fellow at George Washington University, and Research Fellow at the Institute for Strategic Studies under the President of the Republic of Kazakhstan. At the OSCE Academy, Berikbol's research focused on the representation of China in Kazakh society through examining history textbooks, higher education outputs, and knowledge of history scholars in Kazakhstan.

Mr. Mukhammadsodik Donaev is a PhD candidate at Zhejiang University in Hangzhou. His research interests include Central Asian media space, Media Imperialism and the Influence of Foreign Media in Shaping Public Opinion. Mukhammadsodik holds a Bachelor's degree in English Language and Literature from Uzbekistan State University of World Languages and a Master's degree in Public Administration from Zhejiang University. Previously, he was a reporter for an Uzbek media, member of "Zakovat Intellectual Club" and Associate Leader of the "Union of Youth" in Tashkent. At the OSCE Academy, Mukhammadsodik's research focused on examining Uzbekistan-China relations through the lenses of the Shanghai Cooperation Organization, commercial cooperation and media engagement.

Ms. Niva Yau's research interest follows Global China affairs with a particular focus on China's foreign policy, trade and security in its western neighbourhood, including Central Asia and Afghanistan. 
### ASYLGUL KANATBEKOVA (SENIOR PROJECT RESEARCH ASSISTANT, GEC)

# CAREC INSTITUTE'S RESEARCH GRANT ON DIGITALIZATION OF INFRASTRUCTURE AND DECARBONIZATION IN CENTRAL ASIA

In the year of 2023, the three Post-Doctoral Research Fellows of the OSCE Academy – Dr. Rahat Sabyrbekov, Dr. Aizhan Sharshenova and Dr. Burulcha Sulaimanova received a research grant from the CAREC Institute within the framework of its "Leveraging Digital Technology for Green, Sustainable and Inclusive Growth", CTTN Research Grants Program.

The Post-Doctoral Research Fellows of the Academy conducted a year-long research study on the topic of "Digitalization of Infrastructure and Decarbonization in Central Asia: Opportunities and Challenges" to develop a research-based report with policy recommendations for Central Asian governments. The results of the study will be published and shared with the public in the year of 2024.

### LIBRARY



The Library at the OSCE Academy serves as the central place for information, supporting both the educational curriculum and ongoing research activities. It houses a specialized collection focusing on political science, economics, and development, with particular emphasis on International Relations, Conflict and Security Studies, Economic Governance, Human Rights, Development Studies, Comparative Politics, and Political Theory. This collection is curated to meet the needs of the Academy's programs and the requests of faculty, students, and researchers.

In addition to its physical collection, the library has subscriptions to several databases, including EBSCO, JSTOR, and T&F, providing access to academic journals, articles, and other scholarly materials. Furthermore, as a member of the Kyrgyz Library and Information Consortium (KLIC) within the EIFL (Electronic Information for Libraries) network, the library enjoys complimentary access to various electronic resources, including the Oxford Journals Collection, Cambridge Journals Online, IMF Electronic Library, SAGE Journals, OECD, Mathematical Sciences Publishing House, and De Gruyter eJournal.

To enhance accessibility and facilitate research, the OSCE Academy Library offers a digital repository for Master's Theses, powered by DSpace software. This repository enables students to create and share their digital portfolios, contributing to the dissemination of academic knowledge and fostering scholarly communication within the Academy community.



In the beginning of 2024 the OSCE Academy Alumni Network welcomed 36 newly graduated members to its ranks, totaling the overall number of our alumni to 655 (340 women and 315 man).

We conduct an annual Alumni Survey to study the employment track of our alumni, as well as to maintain connections within our network, further improve the quality of our work to engage our graduates in various collaborative initiatives, and tailor our projects to their professional and academic needs and expand the Academy's assistance and input into growing, and empowering the Alumni Network. Our latest Survey<sup>1</sup> revealed that 74 per cent of the Alumni, those originally come from Central Asian countries and Mongolia, live and work in the wider Central Asia region. Of the total number of alumni, it makes 66 per cent.

36 per cent of employed alumni hold senior positions, such as Directors, CEOs, Heads of departments, Managers and Officers working for the Central Asian governments, international organizations, education institutions and NGOs. 32 alumni who chose an academic path, are currently doing their PhD.

## INTERNATIONAL SPRING SCHOOL ON HUMAN SECURITY AND GOOD GOVERNANCE CONDUCTED IN TASHKENT

On **16-20** April **2023**, the five-day International Spring School on "Human Rights & Good Governance for Security in Central Asia," organized by the OSCE Academy in Bishkek in co-operation with the OSCE Programme Office in Bishkek and the Global Campus of Human Rights in Venice with the support of the OSCE Project Co-ordinator in Uzbekistan, was held in Tashkent, Uzbekistan. The school brought together 20 graduates and students of the OSCE Academy and the University of World Economy and Diplomacy in Tashkent. The participants representing France, Kyrgyzstan, Tajikistan, and Uzbekistan, discussed such topical issues as human rights, security and good governance in Central Asia.



### ALUMNI TRAINING: THE ROLE OF THE SECURITY SECTOR IN STABILITY AND PEACE IN THE REGION

From **16** to **21 July 2023**, fourteen OSCE Academy students and alumni from Afghanistan, Kazakhstan, Kyrgyzstan, Mongolia, Tajikistan, and Uzbekistan came together to learn about contemporary security sector governance and reform (SSG/R) concepts, taking the opportunity to think critically, to use different approaches, and to evaluate "when, where, and why" to apply SSG/R tools in the Central Asian context – including in light of the situation in Afghanistan. The holistic nature of security sector governance and reform (SSG/R), the transformations experienced by different countries, and the efforts still required to further improve security sector governance in Central Asia were discussed at an OSCE workshop, held at the picturesque Issyk-Kul lake.



### JOINT EXPERT/ALUMNI CONFERENCE "CENTRAL ASIA: COMPREHENSIVE SECURITY AND SUSTAINABLE DEVELOPMENT"

One of the most extensive events was the Annual Alumni Conference. This significant event brought together experts, scholars, and graduates to deliberate on pressing issues under the theme "Central Asia: Comprehensive Security and Sustainable Development." The Conference was held at the OSCE Academy on **November 4-5**, which was co-organized by the OSCE Academy and the University of Siena, Italy (for more details please see pg. 31).



### **ONE-YEAR-STAY AT NUPI FELLOWSHIP**





### **NEW ERASMUS+ PROJECTS**

### Central Asia — Governance, History, Anthropology and Neighborhoods (CAGHAN)

The OSCE Academy is part of the Erasmus Mundus Design Measures (EMDM) – (ERASMUS-EDU-2022-EMJM-DESIGN) project to develop CAGHAN, an Erasmus Mundus Joint Masters on Central (Eur)Asian Studies project. The project is coordinated by Dr. Jeroen Van den Bosch, Adam Mickiewicz University, Poznan. The end goal is to set up a unique, 2-year Master program (Area Studies) on Central Asian Studies (CAS) aimed at providing indepth knowledge and skills to future specialists on this "region" (both in its narrow and broader understanding). Beside instruction on three of the region's titular languages (but also offering Russian), courses are to be drawn from a multidisciplinary program, encompassing History, Political Science, as well as Sociology and Anthropology, supported by their relevant methodologies. The partner universities that will host students for one semester are: Adam Mickiewicz University in Poland, Humboldt University in Germany, and the OSCE Academy.

### Jean Monnet Module "European Climate Policy"

In 2023 the Jean Monnet Module "European Climate Policy" project was successfully launched with its first cycle. Following the module on European Politics, taught by Dr. Clara Portela from the University of Valencia in Spain in April, in May Dr. Rahat Sabyrbekov, Postdoctoral Research Fellow, and Jean Monet Project Coordinator, taught the first module on European Climate Policy. The first objective of the module was to provide students with a broad understanding of the key issues and challenges related to EU climate policy in Europe, as well as the skills and knowledge needed to analyse and evaluate policy options. The second objective of the module was to see how the lessons from EU climate policy can be learned to implement successful decarbonization strategies in Central Asia. This module was attended by students of the OSCE Academy and AUCA.





As a second component of the project, on 11 April 2023, the OSCE Academy in Bishkek organized a roundtable on "Climate Policy in Central Asia and Research Potential" moderated by Dr. Sabyrbekov. Representatives from the government of the Kyrgyz Republic, non-profit organizations, international organizations, and universities in Central Asia took part in the event. The objective of the round table was threefold.

Firstly, it aimed to convene stakeholders to deliberate on the prevailing state of climate policy within the region. This included an examination of existing initiatives, challenges encountered, and areas requiring further attention or improvement. Secondly, the meeting sought to foster collaboration and knowledge-sharing among participants, drawing from the experiences and lessons gleaned from EU climate policies. By studying successful strategies implemented in the EU, the round table aimed to identify transferable practices and methodologies applicable to Central Asia's context. Thirdly, the session aimed to be a platform for the development of actionable plans and strategies. Through robust discussions and evidence-based insights, participants were encouraged to formulate concrete steps and initiatives that could effectively contribute to the region's decarbonization objectives. Emphasis was placed on devising approaches grounded in empirical evidence, ensuring that the proposed strategies were based on reliable data and analysis.

During the round table, Nurzat Abdurasulova, President of the Unison Group; Saikal Esenamanova, Lecturer at the Kyrgyz Economic University; and Nazira Esenalieva, Alliance of Universities for Green Economy and Sustainable Development (AVZUR) discussed the current state of climate change in Central Asia and its impact on the region's economy, health and natural resources. National climate strategies and action plans adopted in Central Asian countries were discussed, including measures to reduce greenhouse gas emissions, support renewable energy sources, and the sustainable use of natural resources.

Participants stressed the significance of consolidating researchers from Central Asia to conduct joint scientific and educational events in the field of climate change. They also identified priority areas in climate policy research, discussed issues related to the education and training of relevant specializations at universities, and considered opportunities and obstacles for publication in international journals.

In summary, the round table served as an important forum for stakeholders to collectively assess the current landscape of climate policy, leverage international best practices, and collaboratively chart a path forward towards sustainable and evidence-based climate action in Central Asia.


