Previously, he worked as a Senior Research Fellow at the Eurasian Research Institute of Akhmet Yassawi International Kazakh–Turkish University, where he contributed to Institute’s work on energy, finance, and security. Farkhod Aminjonov holds a Ph.D. in global governance from Wilfrid Laurier University/ Balsillie School of International Affairs, Waterloo, Canada. Dr. Aminjonov has experience conducting research within a number of collaborative projects with the Canadian, German, Norwegian, U.S. and Turkish think tanks. He also has a track record of publications (journal articles, reports, policy papers, etc.) and a teaching experience in Canada and Kazakhstan. Dr. Aminjonov is an expert on energy security and trans–boundary water management with a particular focus on Central Asia and the broader Eurasian region.
