### Transdisciplinary research/ education for sustainable development workshop

**Date:** 16-19 June 2025 **Venue:** OSCE Academy in Bishkek, Botanicheskiy pereulok 1A

### **About the Training**

Transdisciplinarity responds to the complex challenges of sustainable development and green transformations. While there is no single definition of transdisciplinarity, two features are usually prominent: Firstly, researchers and lecturers are integrating the knowledge of relevant stakeholders from politics, business, arts and society more strongly into the research process or even conducting research together with these stakeholders (co-creation). Secondly, transdisciplinarity is not only concerned with analysing problems, but also with identifying and studying solutions, including their implementation. The aim is to integrate diverse knowledge resources such as academic, experiential and performative knowledge and transfer them into the context of real-world challenges in order to develop practical solutions and generate new academic knowledge.

This 3,5-day workshop introduces the basics of transdisciplinary education and research with a special focus on sustainable development. Participants will explore key concepts, theoretical foundations, and selected methods such as Living Labs, Citizen Science, Entrepreneurship Education and Storytelling. Tailored for academics to cross disciplinary borders and address real-world problems, the session presupposes no prior experience with transdisciplinary approaches.

On the first day, Dr Thorsten Philipp will give an introduction to transdisciplinary education. The second day will see Dr Monika Gonser and Dr Jochen Eckart offering an introduction to transdisciplinary research, using the Living Lab format as an example. On the third day, participants will work in groups to design a transdisciplinary research and education project. The results of this group work will be presented on Thursday morning.

#### **Working Language**

The workshop will be held in English, with simultaneous interpretation into Russian available. Participants may contribute and ask questions in Russian. Group work will also be conducted in Russian.

#### **Workshop Output**

In order to facilitate a debate on the prospects and challenges of TDER in the Central Asian higher education landscape, we would like to use the training as an opportunity to co-produce and publish a publication in Russian and English together with you. The main target audience will be higher education experts and lecturers as well as policy makers and other relevant

stakeholders. The publication will provide a brief overview of TDER, but will also include the main outcomes of the exercises and discussions during the training.

### **Organizers, Trainers, and Moderators**

The **OSCE Academy in Bishkek** is a public foundation that promotes regional cooperation, conflict prevention, and good governance in wider Central Asia through postgraduate education, professional training, and intellectual exchange. **Professor Dr Monika Gonser** has extensive experience in the theory and practice of transdisciplinary research and education. She is a sociologist and an expert on cross-sectoral collaboration, as well as being the head of the Intersectoral School of Governance BW in Heilbronn. Prior to studying sociology, she trained as a Russian interpreter in Moscow. She also has expertise in intersectoral dialogue and sociological accompanying research.

**Professor Dr Jochen Eckart** holds the Chair of Transport Ecology at Karlsruhe University of Applied Sciences. He has extensive experience in transdisciplinary research with real-world laboratories. He heads the ongoing R&D project 'Collaboration for Active Mobility in Africa CAMA' under the programme 'Partnerships for sustainable solutions in sub-Saharan Africa' (BMBF and DAAD), which develops real-world laboratories to promote active mobility in cities in sub-Saharan Africa. He was also one of the leaders of the R&D project 'ReallaborGO-Karlsruhe', which deals with the effective promotion of pedestrian traffic. As part of this project, he investigated the involvement of stakeholders in transformation processes. Professor Eckart has international experience with projects for the World Bank (Kenya and Uganda) and the Baden-Württemberg Foundation (Philippines).

**Dr Thorsten Philipp** is a political scientist and communication scholar. As an advisor to the Presidium of TU Berlin, his mission is to promote inter- and transdisciplinary education in the interplay between the university, business, culture and society. Thorsten Philipp is lecturer at various universities in Germany, such as Freiburg und Passau. In his own research, he analyses pop music as a sounding board for ecological crises. Recent publication: Handbook Transdisciplinary Learning (transcript, 2023).
